District Benchmarks

Good News:

Throughout the spring, MJUSD consultant Maria Nielson will be visiting sites to help staff "unpack" the California State Standards and begin the process of creating site-based interim assessments. This endeavor will allow sites to become more autonomous in the establishment and administration of formative benchmark assessments for their students. These site-based assessments will guide teachers in identifying areas of academic strength and areas in need of enhancement for their students. goal is to provide teachers with relevant and timely data to modify and adjust teaching strategies to meet specific student needs. This process necessitate grade-level and/or content area staff working together to agree on the foundational concepts and skills students need to know and be able to demonstrate to be successful in the coming year.

Once the agreed upon site-based assessments are loaded into Illuminate, the site will no longer be required to administer the MJUSD Benchmark or end -of-unit assessments. Rather, each site will measure student progress utilizing the essential standard formative assessments they have created.

Bad News:

Until the site-based formative assessments are created, the MJUSD Benchmark assessments and/or end-of-unit program assessments will need to be administered by the site.



The Wellness Committee has been progressively working to bring MJUSD into compliance with this regulation since the 2007-08 school year. Most recently during the 2015-16 school year the committee: assisted in the notification & implementation of policy revisions, provided site-level training and support for the Wellness Policy Annual Evaluation, and collected and analyzed data from the Wellness Policy Annual Evaluation.

Summary of Evaluation Data

Best Practices

Schools are aware of the Wellness Policy and continue to find ways to improve on-site initiatives promoting healthy behaviors. Nutrition Education is facilitated through of the Harvest of Month and Dairy Council curriculum, STARS, and UC CalFresh. Nutrition Services offers a variety of fresh fruit and vegetables and has decreased offerings of pre-packaged foods while meeting federal regulations. An "Approved Food List" for fundraisers and student groups promotes a positive relationship between these groups and Nutrition Services which encourages healthy behaviors for our students both at school and at home. Health Services continues to push boundaries with outreach initiatives.

Local and statewide community partners have recognized MJUSD as a leader in implementation of the School Wellness Policy and Evaluation. Amber Watson, Director of Nutrition Services, has been asked to speak on both a local and statewide level about our best practices and procedures for bringing our district into compliance with this regulation.

Ed Senvices—New English Leanner Reclassification.....

New guidelines for English Learner Reclassification have expanded to include multiple measures which will make the process easier for students. Form #21 has changed...now when investigating the evidence that ensures a student is at grade level proficiency, site review teams will have additional criteria to monitor:

- Overall CELDT scores of Advanced or higher, and domain scores of Intermediate or higher.
- ♦ Teacher evaluation including, but not limited to curriculum mastery. Report Card grades may play a part in this evaluation but are not required.
- Parent /Guardian opinion and consultation.
- Basic skills assessment based on overall proficiency on the ELA SBAC, and/or overall proficiency on district benchmarks, including site-based, grade-level standards assessments shared in Illuminate.

have her expertise to add to our team. Jessica is here to support specialized classrooms, staff development, intervention programs, Speech and Language Services, and Health and Nursing.

Cansen Technical Education.....

Career Technical Education (CTE) courses in the district are thriving. CTE courses provide training in many different industry sectors and are geared to prepare students for successful careers through entry-level employment or preparation for advanced training.

The district has been successful in securing grant funding to build quality CTE programs. Through a partnership with Tri-County ROP, we received funding to focus on identified career paths at both comprehensive high schools. In addition, the district was awarded a CTE grant that has allowed us to build capacity to enhance and bolster the CTE learning environment.

Manysville High School

The Sports Medicine clinical lab is undergoing a major transformation. Aquaponics tanks are being added to the Ag complex. A new medical terminology class will be an option in the Health and Medical Technology industry sector next year.

Lindhurst High School

LHS is "cooking" up opportunities for students through their culinary program. Students are broadcasting internet news and athletic events in their new media production studio. The welding program added 18 new welding bays to enhance their lab.

These are just a few highlights of our many CTE programs. More great things are on the CTE horizon as we strive to provide relevant and rigorous learning.



The Air Force Junior ROTC has been cleared for takeoff and will be landing at LHS next school year. The aerospace program will be open to all high school students in the district. LHS is engaged in the process of hiring the commanding officer.

Student and Health Services.....

Based on our December 1 Student Count, we are serving 1,268 students identified with Special Needs. Each of our diverse schools offers a continuum of Special Education supports and services, and several of our school sites provide quite unique program options.

Olivehurst Elementary School is in year one of implementing their Learning Center model. Designed by Special Education Teacher, **Robyn Lynn**, with the assistance of General Education Teacher, **Melissa White**, and the support of Special Education Teacher, **Dan Pingel**, along with our Technology Director, **Bryan Williams**. The Learning Center was funded through a State Department Inclusion Grant; this centerbased approach to serving students with and without special needs is assisting with the federal initiative to serve ALL students in more regular and inclusive environments.

The Learning Center team focuses on students belonging to General Education first and as assessment data is collected, students are provided intervention in alignment with their academic levels. The location of that intervention might be in the general classroom or within the center. As the model grows and expands, students will receive more instruction time in general settings with non-disabled peers and identify less with traditional self-contained classrooms. Teachers will develop more professional and collaborative means of working together to support all kids. This program has literally broken down the walls between general and special education classrooms. Congratulations to the Olivehurst team! Call Student Services if you would like to tour.

New Wheels.....

Four new buses have been added to the Transportation Department fleet. Old 1990 buses were replaced with 2016 models that carry 84 passengers. The old buses could not be retrofitted with particulate traps or other clean technology. These buses were purchased with one time



discretionary funds at a cost of \$162,656 per bus. The old replacement buses were traded in for a cost savings to the district.

One additional new bus is being purchased with grant funding from the Feather River Air Quality Management District. The Blue Sky Grant will pay \$123,634 with the district matching \$40,000. The old bus must be taken off the road and destroyed as part of the grant funding agreement. The Transportation Department is coordinating with local law enforcement and fire agencies to create training opportunities for first responders before the old bus is destroyed.

These new buses are 100 year anniversary model Thomas Built, SAF-T-LINER buses built in Thomas's environmental friendly factory in High Point, North Carolina.

Two MJUSD administrators were recognized by the Association of California School Administrators (ACSA) Colusa-Sutter Yuba Chapter with Administrator of the Year awards on February 9.
