Report to the Board of Trustees

March 25, 2014

Dobbins and Yuba Feather schools are firmly committed to the belief that it takes the school, home, and community working together to ensure student success. We further believe that students are inspired by high standards and challenging goals and will learn at high levels when instruction meets their needs. We continue to strive toward meeting the goals as set forth by the Board of Trustees and the Marysville Joint Unified School District.

Because both Dobbins and Yuba Feather schools are so similar in demographics as well as student population, not to mention they share an administrator, it has been a natural progression to join the two staffs into one professional support team. As a team, we have taken advantage of many opportunities to get together for professional development as well as to plan, set goals, and articulate. This year our focus has been on the implementation of the Common Core State Standards. Everyone at both schools have embraced the transition and are moving full steam ahead...some with a little apprehension as they are slightly overwhelmed, others with extreme excitement as they are either able to once again teach as they used to or have accepted the challenge of learning new things. No matter what the motivation, the end result is the same with our teachers taking advantage of as much CCSS training as they possibly can. There is evidence of Common Core implementation in every classroom!

As a means of meeting our goal of continuous student achievement, both Dobbins and Yuba Feather schools utilize a major percentage of their annual budget toward support personnel in the form of Para Educators, Literacy Resource Technicians, and Intervention Tutors. These additional personnel allow us to decrease our student to teacher ratio as well as provide opportunities for students to receive individual and/or small group targeted instruction and/or intervention in both language arts and math. Both schools are also very fortunate in that they receive additional student support from a variety of programs. The American Indian Education Program provides additional Para Professionals, tutoring and cultural enrichment to our students. The STARS afterschool program is an integral part of our students' day. We feel very fortunate to have this safe and caring environment on both campuses supporting our students with homework help as well as supervised social interaction with friends. A very active parent/teacher group continues to be an advantage of being at a small school. These small but active groups of parents spend countless hours fundraising and planning events for our students. They support our award programs, pay for field trips and assemblies, and provide for us those "little extras" that budgetary restraints don't allow.

Home-school communication is a high priority at Dobbins and Yuba Feather schools. Both schools continue to have an open door policy where parents are encouraged to take an active role in their student's education. A newsletter is sent home every month keeping parents apprised of school happenings, helpful information and tips, and upcoming events. Parents are also encouraged to attend monthly gatherings to see student performances, recognition, and celebrations. Regular contact with parents is also made via conferences, notes and phone calls home, and weekly homework/class work notices. The phone dialing system is used on a regular basis to communicate with parents as well.

The beautiful campuses with their family-like atmospheres, amazing staff, and terrific students make Dobbins and Yuba Feather schools the exceptional schools they are!
