Our Parent Teacher Staff Organization has a Volunteer Coordinator who hosts both the Arboga Elementary School PTSO and Arboga Elementary School Facebook pages, posting information about upcoming events, ways to volunteer, soliciting ideas, etc. The school coordinates and integrates the Title I parental involvement program with other programs, and conducts other activities, to encourage and support parents in more fully participating in the education of their children.

- 5. Distributes to Tile I parents information related to school and parent programs, meetings, and other activities in a form and language that the parent understands. Information sent out to parents via printed media or vocal messages goes out in our two required languages, English and Spanish.
- 6. Provides support for parental involvement activities requested by Title I parents. Through the use of the administration and counseling support is provided to all parents who are looking to help their students either academically or socially.

Accessibility
