This room is child friendly with toys, books, and activities for children 4 years and younger to do, so small children are welcome. This year due to the Covid 19 pandemic, our meetings will be virtual, via Zoom. This presents an opportunity to hold meetings later in the day, after parents are done supporting their children with distance learning. All Ella students were given a Chromebook for distance learning, which supports parent access to a technology device for the meeting. Hot spots were also provided by the district for families who did not have internet access. We can also record the meeting so parents can watch the meeting at a later time when it is convenient, if they cannot attend the live Zoom meeting. Zoom meetings are scheduled to take place at 1:00 pm on the first Monday of each month. These meetings will be in English with Spanish translation.
