



# MJUSD 2025-2026 Assessment Calendar

MJUSD conducts internal (MJUSD-developed) and external (State-mandated) assessments to support teaching and learning. At the district level, assessments are used for reporting purposes, data analysis and shows overall trends across schools and supports big-picture decisions about policies and resources. School site data is more focused on students and classroom, helping guide instruction, monitor progress, and plan interventions.

These assessments are annually scheduled on the calendar to allow for consistency with implementation and alignment across the district.

## MJUSD Assessments

Starting 2022-2023, MJUSD expects every classroom to conduct the universal screener and the common grade-level assessments developed during the 2021-22 school year. The data from these assessments provide teachers and administrators with critical information to design student success supports, including teacher workshops, intervention, and acceleration options for improved and increased student engagement. These assessments are annually scheduled on the calendar to allow for consistency with implementation and alignment across the district.

### Universal Screening

**The district will conduct the STAR Ren ELA and Math in grades 2-8 and 1st grade for math twice a year to identify learning gaps at the beginning and annual growth at the end of the year.**

#### WHY do we conduct the Universal Screener?

Universal screening is a critical first step in identifying students at risk for experiencing reading or mathematics difficulties and needing more instructional support. STAR Renaissance is being used as the universal screener, a nationally norm-referenced assessment used to determine if a student is making expected progress to succeed academically at grade level. Information gathered from Universal Screening will support tiered intervention, acceleration, Student Study Team (SST) decision-making, 504 Plans, IEPs, English Learner Reclassification, and Special Education Least Restrictive Environment placements. **All 1-8 students in MJUSD will take part in the universal screening process. District data will be available for students in grades 9-12 that assess during the optional window.**

## California Reading Difficulties Risk Screener (RDRS)

An LEA serving pupils in kindergarten or grades one or two must administer the screener for risk of reading difficulties, including possible neurological disorders such as dyslexia beginning no later than the 2025-26 school year, and annually thereafter. *EC 53008(e)*

In determining when during the school year to administer each screening instrument, an LEA must consider whether pupils have received sufficient instruction in foundational reading skills to support a valid assessment. Note that this requirement does not restrict LEAs from providing additional pupil screenings or diagnostic evaluations, as appropriate. *EC 53008(e)*

## MJUSD Assessments

### What is a common assessment?

*A common assessment is any assessment given by two or more grade/subject level teachers with the intention of examining the results. Through a collaborative process that included analysis of state standards and board-adopted curriculum, teachers and administrators in the Marysville Joint Unified School District have identified the essential standards that make up MJUSD's guaranteed and viable curriculum. This assessment and data are used for*

1. Teacher planning and collaboration are needed to increase and improve academic rigor and ensure that all students are supported in mastering the grade-level standards.
2. Data is also used to support SST, 504, IEP, and EL Reclassification meetings.

## GATE TEST

The primary goal of the GATE program is to provide gifted students with the opportunity to reach their full academic potential. Identification for GATE typically involves a combination of standardized test scores, teacher recommendations, and parent input. MJUSD uses Pearson NNAT3 as the assessment tool.

## State Assessments

### ELPAC Assessment

The ELPAC is the State test used to measure how well students in K12 understand English when it is not their primary language. Information from the ELPAC helps your child's teacher provide support in listening, speaking, reading, and writing.

**The data is used for:**

1. EL placement, instructional support during designated and integrated ELD, and reclassification to RFEP.

Initial Assessment

July 1, 2025, through the end of school

Annual Assessment

February 1 through May 31, 2026

### CAASPP Assessment

The California Assessment of Student Performance and Progress Administration includes the Smarter Balanced Summative Assessments, the California Alternate Assessments (CAAs), the CAA for Science, the California Science Test (CAST), and the California Spanish Assessment (CSA). CAASPP data is a powerful indicator of student achievement of grade-level standards.

**The data is used for:**

1. Teacher individual lesson planning and PLC collaboration meetings and professional development.

### California Reading Difficulties Risk Screener (RDRS)

In determining when during the school year to administer each screening instrument, an LEA must consider whether pupils have received sufficient instruction in foundational reading skills to support a valid assessment.

The legislation requiring the screening of pupils for risk of reading difficulties includes findings and declarations that speak to the purpose of the screening for risk of reading difficulties. Specifically,

- Screening pupils for risk of reading difficulties, including dyslexia, is one of many tools that educators can use to gain information about how to support pupils' learning.
- Early identification and intervention with evidence-based early literacy instructional strategies and materials improves literacy outcomes for pupils at risk of, and with, reading difficulties, including dyslexia.
- By screening all pupils for risk of reading difficulties early, California can help families and teachers achieve the best learning and life outcomes for all pupils and close academic achievement gaps. *Education Code Section (EC) 53008(a)(1)(2)*
- Results of a screening assessment must not be used for any high-stakes purpose, including the reclassification of those classified as English learners. *EC 53008(m)*

### PFT Assessment

Since 1996, California Education Code (EC) Section 60800 has required that each local educational agency (LEA) administer a state-designated physical fitness test (PFT) to all students in grades five, seven, and nine. The test designated for this purpose by the State Board of Education is the Fitnessgram®.

**The data is used for**

1. Public access to this data is required as part of the EdCode. PE teachers can plan their lessons and align TK-12 activities accordingly.

PFT- grades 5, 7, 9

Feb 1- April 30, 2026

### AP Exams:

The main reason to take an AP exam is to demonstrate mastery of rigorous college-level material. By scoring a passing grade on an AP exam (3 or above), you can earn college credit at most colleges and universities in the US and Canada.

**The data is used for**

1. Teacher support is provided for student preparation for the tests.
2. Used as a College and Career Indicator for School Sites.
3. Measures Equity and Access to highly rigorous preparation for four-year college access

# RENAISSANCE STAR STUDENT AND STAFF SIGN-IN DIRECTIONS

## Teacher Directions:

- Have students log into Clever and select the Renaissance tile
- Students will choose the test that is being administered
- Students will type in the password: admin
- Students will be prompted to select the button to begin the test

## Teacher Responsibilities:

- STAR Renaissance accounts are managed through the district, and students are rostered automatically.
- The assessments are always available to teachers and require no additional planning or prepping.
- Teachers will administer the assessment to every student in their class, including students on an IEP.
- The data will be one of the many measures used to determine student interventions and supports.
- Send home parent STAR report.

## Principal Responsibilities:

- Principals will ensure that the Universal Screener is administered during the screening window and when new students are enrolled.
- The data will be one of the many measures used to help determine student interventions and supports.
- This data should be discussed within staff meetings and play a significant role in the sites' intervention plan.
- The intervention plan will be shared with the Director of Data and Student Improvement.
- Ensure STAR parent report is sent home.
